Septic Tank Replacement Only (Includes Review/Application Fee)	\$200

Please note: A late fee of \$50 will be charged for any facility installed or operated without a permit for over 30 days. A late fee of \$100 will be charged for any facility installed or operated without a permit for over 60 days. Permits that have expired for over 90 days will be confiscated and/or other appropriate legal action may be taken.
