1. If the court grants your application to Set Aside Conviction, it must also issue a Certificate of Second Chance if you have not previously received a Certificate of Second Chance and any of the following conditions apply:
 - a. You were convicted of a misdemeanor.
 - b. You were convicted of a Class 4, 5, or 6 Felony and at least 2 years have passed since you fulfilled the conditions of probation or sentence; or
 - c. You were convicted of a Class 2 or 3 Felony and at least 5 years have passed since you fulfilled the conditions of probation or sentence.

What is Certificate of Second Chance

Certificate of Second Chance grants the opportunity to obtain an occupational license, provides protections to employers for hiring or contracting with ex-offenders, and provides protections to a person or entity providing housing to an ex-offender.

The Certificate of Second Chance cannot be used as a recommendation, sponsorship, or promotion when applying for an occupational license, employment, or housing.
